I had a call, not long ago, from a fellow who was trying to reach the Texas Rivers Protection Agency. It turned out that he had reached the right organization; he just had the wrong name (and, I'm sure the wrong impression of what we are about). We are not an agency of the State of Texas. In fact, we are a totally voluntary organization (no paid staff, no office, no utilities etc).

So, I thought it might be interesting for ya'll to hear the story from start to finish on how we were able to stop a bad water quality permit from being granted by the Texas Commission on Environmental Quality (TCEQ) to the City of Castroville.

It all started while I was in the waiting area of the birthing center of Memorial Hospital in Sugarland. My daughter Sandy was about to give birth to our first grand baby, Eden. It was late November of 2007. I got a call from a fellow named John Hall who lives on the Medina River just downstream of Castroville. He said that Castroville had applied for a permit to discharge their sewage effluent into the river and he wanted to know what he could do to stop them.

I walked him through the process: first, he needed to request a public meeting; then he needed to line up some people who lived close enough to the point of discharge to be able to acquire party status, then we needed to request a contested case hearing. Once we reached that stage, I felt confident that Castroville would negotiate and we could at least get the best possible treatment for the effluent. And, since the effluent was currently being used to irrigate farmland, I felt pretty sure that that process could continue.

Thanks to the amazing diligence of John Hall and Byrde Wagner, and of Bill Bunch and Andrew Hawkins (lawyers for the Save our Springs Alliance who agreed to help us with the case) we were finally able to get our contested case hearing set (TCEQ originally denied our request but an appeals judge said otherwise).

We had been told by the city that the farmers would not negotiate a long term contract; and we had been told by the farmers that the city would not negotiate; and, for these reasons, irrigation was no longer an option. But Bill Bunch was able to get the farmers and the city to sit down for a talk, and it turned out that their differences weren't impassable. A settlement was reached, in 2013, and the city agreed to treat their effluent to a higher standard in the event that they ever have to discharge it into the river.

So, an expensive hearing was avoided, the farmers can continue to use the "wastewater" for a beneficial use, and the river will benefit by having less nutrients dumped into it. All because John Hall made a call, and a lot of volunteers were willing to do their part to protect Texas Rivers.

So, that's how we roll: we depend on volunteers like John Hall and Byrde Wagner and Board members like Steve Daniel who keeps Hidalgo Falls maintained, and Ed Lowe who does amazing things to protect the Brazos and Rich Grayson and Marcos Paredes for serving two terms on the Devils River Working Group and Rich's work to keep the website updated and lawyers like Bill Bunch who work so hard for so little, and John Erskine for working with the kids in Austin to get them interested in protecting rivers. And let's not forget Joe Riddell, who spent last summer preparing a critique that helped open the highway right of way at Bakers crossing (which had been closed, by the state, as a public put in). And then there is your generosity with your financial support. Ya'll keep us rolling. Thanks

## News

**Hidalgo Falls Fund:** In April 2001, thanks to contributions of more than \$65,000 by 160 individuals and paddling organizations throughout Texas, TRPA was able to purchase 10.1 acres of property at Hidalgo Falls on the Brazos River near Navasota. Since then, hundreds of canoeists and kayakers from across the state have used the property, developed camping facilities there, and spent many hours clearing debris. In March 2003, another sixty paddlers, with the support of local, state, and national groups, donated an additional \$17,000 to acquire two more acres. In November 2003 we sold three of our acres downstream of the rapid, and with \$15,000 contributed by another thirty paddlers, we added another four acres immediately overlooking the rapid. In 2009

and 2010 paddlers again contributed over \$25,000 to drill a water well, install a septic fields, and build a bathhouse (with toilets, showers with hot water, and lavatories).

**River Road Fund:** The State of Texas is considering allowing an interstate type highway to be constructed across the Guadalupe River along River Road. We have set up a fund to help the locals defeat this project. You can read more at: <http://www.save-river-road.net/>

**Rockcrusher Fund:** Several years ago a company called Wheatcraft applied for an air quality permit for a rockcrusher on the banks of the Guadalupe River and right in the middle of the town of Center Point. Partly due to our opposition, that company has temporarily withdrawn their permit application. The fund is still maintained in the event that the issue comes up again.

**Center Point Lions Park:** A group in Center Pont are interested in improving a small park on the banks of the Guadalupe River.

**Mike Ash Memorial:** A fund maintained to remember an old friend of Texas Rivers. The money is periodically donated to projects that we feel Mike would have liked to support.

**Nuisance Lawsuit, San Marcos River:** There are several tubing operators on the San Marcos River that are particularly offensive when it comes to trash, noise and bad behaviour. A group of local members raised the \$1,600 that was required to study the legal requirements to instigate a nuisance lawsuit against those businesses.

And, we just learned today (January 27) that the New Branufels Disposable Container Ban has been overturned by the courts. So, it's starting to look like a nuisance lawsuit might be the best recourse for this organization to use to try to control the bad behaviour (especially the littering) that is taking place on the San Marcos River (and other rivers wherever tubing is popular). At an rate, it looks like we will be actively involved, in the coming months, in trying to take back Texas Rivers from the scumbags who are destroying them.

## San Marcos River Clean Up 29th Annual - March 1, 2014

On Saturday, March 1, folks from all over Texas will be participating in the world's longest river clean up. We will be picking up trash along the entire length of the San Marcos River (approximately 90 miles). Everyone is urged to help. If you are unable to participate in the water, we need volunteers to work the banks of the river, especially at parks and highway crossings. The upper sections of the river will require the most attention, and the short mileages set for these sections reflect this. Furthermore, the river becomes less accessible and more hazardous as one goes downstream. For that reason, novice boaters should volunteer for the upper sections. The lower river, from Luling to Gonzales, has several long sections with few bridge crossings so we are asking canoe racers (especially teams that have competed in the Texas Water Safari) to volunteer for sections below Luling. Everyone participating in this event is invited to camp free at either Shady Grove Campground/ Spencer Canoes or at the San Marcos River Retreat for the weekend. Starting at 6 p.m. on Saturday evening there will be a meal provided by the San Marcos River Foundation at Shady Grove/Spencer Canoes. Canoe racers paddling the lower river will meet at Palmetto Park at 8:30 a.m. Everyone paddling the sections of river between the Thompson's Island and Luling will meet at 9:00 a.m. Saturday morning at the San Marcos River Retreat. Persons working the upper sections will meet at City Park in San Marcos at 9:30 a.m.

## Bios for folks running for TRPA offices and board positions

**Tom Goynes** has been paddling canoes and kayaks since 1967. He has served as president of the TRPA since its inception (in the late 1980's). He and his wife, Paula, own a campground and have lived on the San Marcos River since 1972.

**David Reichert** started canoeing at Bull Creek Lodges in the mid-50's and got into whitewater paddling in the early 70's. He is a founding member of TRPA and has been active in ACA (BOD, NIC, Safety Committee, Public Policy & Conservation Board), TRRA & USCKT (slalom judge & race organizer; trained as junior sprint coach). He runs the CanoeTX e-mail list and was certified by ACA & Red Cross to teach river canoeing. He was an ACA swiftwater rescue instructor trainer and had SRT II certification. He and his wife Modrea live in San Antonio.

**Duane TeGrotenhuis** has served as a TRPA board member from its very beginning. He assumed roles of vice president and treasurer. Along with Evelyn, his wife, he owns and operates T G Canoes and Kayaks with two locations at San Marcos and in Austin, as well as Buchanan Adventure Tours at Canyon of the Eagles, on the Colorado River and Lake Buchanan, near Burnet, TX. TGCK has been serving the San Marcos River for 25 years and running.

**Jim Hatcher** (Fort Stockton) Has served on the board of the TRPA for many years. Often represents our interest in the Big Bend area.


**John Hohn** (San Marcos). Has served as a lawyer for the TRPA in several cases. Loves the rivers of this state and spends a lot of time protecting them.
